Newly Launched Mahoning County Special Needs Registry Provides Lifesaving Information

The Mahoning County Prosecutor's Office, in joint collaboration with the Mahoning County Sheriff's Office and the Board of Mahoning County Commissioners, is pleased to announce the creation of the Mahoning County Special Needs Registry. The Registry is a wonderful and extremely useful tool that will allow citizens of Mahoning County to have direct communication with law enforcement and other first responders in times of need. Many people with developmental disabilities, mental health disorders, and other impairments appear atypical which can sometimes cause an issue when they encounter law enforcement. This registry will provide citizens with special needs an opportunity to inform law enforcement about their condition. The focus is to give law enforcement and first responders the tools to understand the needs of those they encounter.

Under this program, critical information is collected through an online application process accessible through a secure portal within the Mahoning County Prosecutor's website at prosecutor.mahoningcountyoh.gov. Once the information is received, a member of the Mahoning County Sheriff's Office uploads all data into the County-Wide Computer Aided Dispatch System for 911 to match information with an individual through his/her name, address and personal identifier, such as a social security number, Driver's License or State Issued ID number. Once this information is uploaded into the Dispatch System, if an emergency call comes in, 911 Dispatchers will receive an audible alert that the individual is on the special needs registry. This alert will then enable the dispatcher to access and disseminate critical data regarding an individual's special needs, including but not limited to information about their cognitive disorder or development disability, triggers associated with the condition, emergency contact information and a recent photograph.

We are confident that the Mahoning County Special Needs Registry will help build bridges between our citizens with special needs and our law enforcement agencies, enhancing their ability to protect and serve our most vulnerable residents of our community.


RETIREMENTS

CRIMINAL DIVISION NEWS

NOTABLE CASES

State of Ohio v. Traeshaun Turner

Defendant Traeshaun Turner was sentenced on August 12, 2021 to a term of life imprisonment with parole eligibility after 25 years after being convicted of Murder, Attempted Murder, Felonious Assault and Having Weapons While Under Disability. The Defendant was convicted after a four day jury trial in which the jury heard testimony that the Defendant shot and killed Ishmael Bethel outside the Southern Tavern in Youngstown and also wounded a juvenile. The Defendant testified that he acted in self-defense, however, the jury ultimately rejected this defense finding the Defendant guilty of all charges. Assistant Prosecutors Nicholas Brevetta and Kevin Day tried this case before the Honorable Judge John M. Durkin.

State of Ohio v. Guillum Chism

The Mahoning County Prosecutor's Office successfully opposed the parole Guillum Chism during a full board hearing held before the Ohio Parole Board on September 14, 2021. Chism was convicted of two counts of aggravated robbery with a firearm specification and one count of attempted aggravated murder in 1989. He was sentenced to a term of 10 to 25 years in the penitentiary for each count of aggravated robbery and 7 to 25 years in the penitentiary for attempted aggravated murder. According to Jennifer McLaughlin, Chief of the Criminal Division of the Mahoning County Prosecutor's Office, a review of Chism's Institutional Report Summary revealed that although he has participated in numerous programs and activities while incarcerated, his disciplinary history includes multiple contraband infractions and a violent altercation with another inmate on May 22, 2020. The Prosecutor's Office opposed this request also arguing that his victim will never be able to put this behind him and get on with his life. The Parole Board agreed, voting 7 to 3 in favor of denying parole.

NOTABLE CASES CONTINUED

State of Ohio v. Stephon Hopkins and Lorice Moore

On November 12th, the jury found Stephon Hopkins and Lorice Moore guilty of murder, attempted murder, and felonious assault. Hopkins, Moore, and another man, Brian Donlow, were back seat passengers in a car driven by Carlos Davis and also occupied by front-seat passenger Christopher Jackson, both from Warren. The three defendants opened fire on the other two occupants, killing Jackson while Davis managed to run away. Jackson was shot nine times and Davis twice, all gun shot wounds in the back.

Hopkins was sentenced to 35 years to life in prison, while Moore was sentenced to 32 years to life in prison. In April, Donlow was convicted following a bench trial and is currently serving a sentence of life in prison without parole plus fourteen years.

Hopkins's and Donlow's sentences are to run consecutive to the sentences imposed for the June 2018 murder of Brandon Wylie.

The Mahoning County Prosecutors Office would like to thank the Youngstown Police Department, specifically Detective Mike Lambert, for a thorough investigation that, in spite of a lack of cooperation from Carlos Davis, yielded the DNA evidence and video confession used to bring justice to the Jackson family. This case was tried by Grand Jury Prosecutor, Michael Yacavone and Assistant Prosecutor, Jennifer Paris. It is our hope that convictions and sentences like these will deter young men from similar acts of senseless violence, using firearms to settle disputes.

The Mahoning County Sheriff's Office was named Law Enforcement Partner of the Year by the U.S. Marshals Office at its annual awards ceremony held on September 16, 2021 at Progressive Field in Cleveland, Ohio. SCAM ALERT!

It's that time of year again! The leaves on the trees have turned and are falling, the temperatures are getting colder, warmer clothes come to the front of the closet, and families are coming together to enjoy the magic of the holidays.

But this time of year also brings out something much less magical: holiday scammers. Whether you are young or old, holiday scammers are looking to make a quick buck off of a number of scams that may be difficult to avoid.

Here are a few different types of scams you can watch out for:

- 1. Charity scams: A study conducted by Network for Good showed that nearly one-third of all charitable giving is done in December. Holiday scammers target and take advantage of this more charitable, holiday spirit by posing as a charity. These scams range from phone calls to fake websites to people standing outside of shopping centers.
- 2. Online Shopping scams: A more recent trend in shopping for the holidays involves searching for the best deals on the most coveted gifts for friends and family alike. Holiday scammers take advantage of this by sending out scam emails or pop-up ads showing incredible deals. These links then redirect you to disreputable websites that harvest your personal information or websites that are infested with malware and other viruses.
- 3. Delivery scams: As many of us start turning to online shopping for the holidays, sometimes we lose track of all the packages coming in. Holiday scammers take advantage of this by disguising emails from UPS, FedEx, or the United States Postal Service to send notifications that you have missed a delivery. Just like with online shopping scams, the links attached to these emails may lead to websites harvesting your personal information or websites that are infested with malware and other viruses.
- 4. Travel scams: With so many people traveling for the holidays, holiday scammers have developed fake travel websites that are meant to look like the real thing. Oftentimes, these website will have travel rates that are just too good to be true. However, while you are putting in your personal information to claim your amazing deals or prizes, these websites are harvesting this information to sell it to the highest bidder.
- 5. Letter from Santa scams: The AARP identified a scam that asks for people to provide information about your kids or grandkids so that "the jolly old elf" can send them a custom gift or holiday treat based on their personal preferences. This information is then sold to the highest bidder and can be used for nefarious means. While some legitimate companies offer something similar, there are many more scams than the real thing with these Letters from Santa.

How do I avoid being scammed: The best thing you can do is to do your homework. If someone asks you to donate to a charity, search for information on that charity. You may be surprised about what you learn, and you may find a great cause to support, but you may have just avoided a scam and can help others do the same. If you weren't expecting a package, then go back into your records and double-check that you aren't forgetting something. If you don't recognize a website that is offering deals that are just too good to be true, do your research and look into whether this website is real before clicking on the link. You may find out that this website is a great new source for deals, but you may find out that this website is up to no good.

Warning signs: Some of the warning signs that make it easy to spot holiday scammers are: offers of huge discounts, spelling errors and shoddy grammar on a website or in an email, travel sites that do not list addresses or phone numbers to contact the company, websites that do not have privacy policies, and unsolicited emails that come from an email address you do not recognize.

AMERICAN RESCUE PLAN MONIES UPDATE

In March 2020, the COVID-19 pandemic hit the United States in full force, and our lives were all changed in countless ways. One of the effects of the COVID-19 pandemic was a huge financial hit to individuals and communities across the entire country.

In response to some of the systemic issues caused by the COVID-19 pandemic, the federal government took action and approved the Coronavirus Aid, Relief, and Economic Security (CARES) Act as a financial stopgap in the middle of 2020. The federal government was then able to take another step in 2021 and passed the American Rescue Plan (ARP). The short-term goal of both CARES and ARP is to help provide some financial stability to local communities so that they can in turn reach out and provide direct assistance to individuals who need the most help. The long-term goal of both CARES and ARP is to turn that stability into a constant and long-lasting way of life.

Together, CARES and ARP have provided Mahoning County a historic opportunity to strengthen our community through targeted social service programming and infrastructure improvements. In order to do this properly and to make sure that funds go to the right place, Mahoning County has entered into countless contracts with many more improvements and contracts on the horizon.

That's where the Mahoning County Prosecutor's Office comes in. To date, the MCPO has advised the Board of Mahoning County Commissioners on contracting involving over twenty million dollars (yes, \$20,000,000.00) in American Rescue Plan Allocations.

Some of the early projects that have been funded include: \$1,000,000.00 to the ABC Water District for the construction of a new storm water park on the former Market Street Elementary School property; \$40,000.00 to the Hope House to continue meeting the need in our community for supervised visitation; \$500,000.00 to Y.N.D.C. for emergency home repairs throughout Mahoning County; and \$3,000,000.00 to Valley Partners to assist small business and non-profit agencies with the challenges posed by the COVID-19 pandemic. Without the CARES and ARP funds, none of these projects would have been a realistic possibility.

But the best is yet to come! The MCPO is excited to continue working with the Mahoning County Commissioners as we all work to turn the challenges of the COVID-19 pandemic into future opportunities to make stability a way of life throughout Mahoning County – both now and for years to come.
