# New initiatives aimed at helping the mental health of law enforcement

Mental Health awareness is a topic at the forefront of society, and this quarter our office took time to speak about the issue. With help from the Mental Health and Recovery Board, Upholders, Oak Hill Collaborative, and the SOAP Gallery, we were able to help spread awareness about mental health for first responders. Our law enforcement and first responders deal with some of the most egregious scenes, whether a crash, crime, evidence photos, etc. These constant horrifying scenes could cause several different issues like PTSD or depression. There are now new initiatives aimed at helping law enforcement receive the treatment they need to continue working their job and assisting Mahoning County. The Mahoning County Mental Health and Recovery Board, the Sheriff's Department, and various other townships throughout this county provide a week-long CIT (Crisis Intervention Training) course for police officers that provide the resources and help them understand how to respond during specific situations.

### State of Ohio v. George Hill

Mahoning County Prosecutor Paul Gains announced that Judge Anthony D'Apolito sentenced George Hill, 46, to life behind bars with a chance of parole after 15 years served. Hill was found guilty of murdering 36-year-old Jennifer Mullen in May of 2020. A jury found Hill guilty of 4 charges: two counts of Murder, one count of Felonious Assault, and one count of Domestic Violence. On May 31, Jennifer Mullen was found unconscious at her house on Shields Road in Boardman. When police arrived, Mullen had sustained brutal injuries to her head and had bruises all over her body. Hill told police that Mullen had an accident after drinking too much. But, upon further investigation, it was clear that Mullen had little to no alcohol in her system at the time of the incident. It was made clear that the injuries Mullen sustained were from abuse at the hands of Hill. Mullen died from her injuries sustained during that deadly confrontation.

### State of Ohio v. Luis Johnson

A Mahoning County jury found Luis Johnson, 24, of Youngstown, guilty of Attempted Murder from a shooting incident that occurred in October of 2020. He was also found guilty of one count of Felonious Assault, with Firearm Specifications, a Felony of the 2nd Degree. On October 12, 2020, Tevin Gregory was shot multiple times outside of a house on Fairfax Street.Gregory told police that someone in a Burgundy Lincoln shot him; he sustained gunshot injuries to his right wrist and abdomen. Officers spoke to several witnesses who described the scene of the crime. Once officers from the Youngstown Police Department located and searched the vehicle, they obtained a warrant for the arrest of Luis Johnson and Tyree Robinson for Attempted Murder. A few days following the shooting, Johnson turned himself over to the US Marshal Service at his mother's house. The evidence showed that Johnson was stalking his ex-girlfriend, whom Gregory was dating. Gregory was gunned down when leaving the home to travel to work.

### State of Ohio v. Robert Shelton

46-year-old Robert Shelton pleaded guilty to Voluntary Manslaughter with a Firearm Specification for the shooting death of Dymond Ortello in the parking lot of the Brothers of Power Nightclub on Logan Avenue. Judge Sweeney sentenced Shelton to 13 to 18 years in prison. Shelton shot Dymond Ortello in the parking lot as club patrons were fleeing in the club, Shelton took a gun from another man's body inside the club and shot Dymond Ortello twice in the back as a city police officer pulled up. Senior Trial Counsel Robert Andrews and Assistant Prosecutor Patrick Fenning handled the case.

### State of Ohio v. Richard Sickelsmith

In May, Judge Anthony D'Apolito ordered a man to pay \$1 million in restitution after pleading guilty to solid and hazardous waste charges involving the closed Sebring Industrial Plating facility. 63-year-old Richard J.

Sickelsmith was sentenced to five years of probation and ordered to pay \$1 million in restitution to compensate the Ohio Environmental Protection Agency and the United States Environmental Protection Agency for the cost of removing the hazardous material and restoring the site to a safe condition. Assistant Prosecutor Martin Hume handled the case. Sickelsmith was ordered to pay at least \$400 of restitution per month during the five years of probation. The Ohio Environmental Protection Agency investigation revealed that Sickelsmith once owned the property where approximately 38,000 pounds of hazardous waste were stored. The company didn't have a permit to store the hazardous materials at the facility.

#### State of Ohio v. Sharday Bing-Dixon

The Honorable Judge Anthony D'Apolito sentenced 35-year-old Sharday Bing-Dixon to 20 years behind bars for causing the death of her 2-year-old son in 2018. Bing-Dixon had previously pleaded guilty to Involuntary Manslaughter and Permitting Child Abuse; both are Felonies of the first degree. Senior Trial Counsel Rob Andrews and Assistant Prosecutor Caitlyn Andrews handled the case.

#### Arguing before the Supreme Court of Ohio

In April, Assistant Criminal Chief, Ralph Rivera, argued before the Supreme Court of Ohio following an appeal in the case of State of Ohio v. Chaz Bunch. Chaz Bunch was convicted for the violent and callous kidnapping, robbery and rape of a YSU student in 2001. The defense counsel argued that Bunch's defense attorney cross-examined an eyewitness without consulting with or calling an expert to question the witness' credibility, thus denying Bunch a fair trial. Assistant Chief Rivera argued that the victim/witness was consistent in identifying Bunch and his co-defendant as her attackers, and utilizing an expert would not have altered the jury's verdicts.

The humane society works closely with nursing facilities, assisted living facilities, and local hospitals. There was also an increase of abandoned animals, which started to say the eviction moratorium was lifted. To ensure that the humane society could keep up with the influx of animals, they suggested they needed another full-time agent to help manage all the calls they continuously received. The Mahoning County Commissioners awarded the Animal Charity Humane Society \$252,000.00.
