

New self defense program aims to educate Mahoning County

On September 28th, 2023, Mahoning County Prosecutor Gina DeGenova launched her new program called S.T.O.P., which stands for Self Defense Trauma Informed Outreach Program. Under S.T.O.P., area residents will receive tips and training on the essential components of self-defense in a safe, trauma-informed environment. This program was developed through collaborations with many area service providers including Mercy Health, YSU Campus Recreation, COMPASS Family & Community Services and the Youngstown Area Jewish Federation. The course is being taught by Mercy Health Chief of Police and certified self-defense instructor, Ryan Bonacci and will be offered several times each year in different parts of Mahoning County. There is no fee to take this class.

Under S.T.O.P., participants receive training on three core components: (1) education on local laws & local victim services; (2) awareness and confidence building; and (3) physical training. The goal of this course is to increase the confidence of participants to enable them to use the skills learned in response to any potential conflict and/or violent incident.

New self defense program aims to educate, protect Mahoning County


Each year, tens of thousands of people across the United States fall victims to aggravated assault. According to Prosecutor DeGenova, "while my office prosecutes those who commit these crimes, I also believe we have an obligation to educate and provide our residents with the skills they need to recognize a dangerous situation and how to help stop it." This is especially true of college students, where studies show that one in every five students will experience some form of assault during their time in college. These staggering statistics, according to DeGenova, is why her office elected to launch S.T.O.P. at Youngstown State University. DeGenova noted "Having young adult children of my own, I can appreciate how important it is to provide this information to college students. If these techniques help prevent one person from becoming the victim of assault, I view it as a success."

S.T.O.P. will empower residents in a supportive & encouraging environment, and teach participants what resources are available if they or somebody they know is experiencing violence at home. Courses were held at the Andrews Student Recreation & Wellness Center for YSU students and the CLWCC (Community Literacy Workforce and Cultural Center) in Campbell. There will be another session open to the public on November 1st at the Jewish Community Center of Youngstown.

Participants will receive a free t-shirt and drink cover.




Community Outreach

Prosecutor DeGenova and Director of Communications Alan Rodges were invited, by Penny Wells, the Mahoning Valley Director of Sojurn to the Past, on a journey to learn about the history of America's civil rights movement and hear the stories of the families directly affected by segregation, Jim Crow laws, and slavery. This trip was a truly an enlightening experience.

During this journey, Prosecutor DeGenova and Mr. Rodges connected with victims of the 16th Street Baptist Church bombing in Birmingham, Alabama, which killed 4 children, and injured 20 others. They were able to speak with bombing survivor, Sarah Collins Rudolph and Minnijean Brown-Trickey, a civil rights activist and one of the first black students to desegregate schools in Little Rock, Arkansas.

Another major impactful element of the trip was The Legacy Museum: From Enslavement to Mass Incarceration, which was built in Montgomery a short distance from a rail station where tens of thousands of black children and adults were trafficked in the 1800s. The museum provides a comprehensive history of the transatlantic and domestic slave trades, the 12-year Reconstruction period after the Civil War, the more than 4,000 lynchings up to 1950, codified racial segregation during the Jim Crow era and mass incarceration in the 20th and 21st centuries. A haunting display includes shelves filled with jars of dirt that marked spots where black Americans were lynched; besides being hung, many were also shot, drowned or burned. Several of the crimes occurred in Ohio, including that of William Taylor, who was lynched in 1878 in Sandusky. Calling it an "era of heartbreak," DeGenova said, the museum amply and dramatically displayed the lack of "basic human rights like what we should have," (Sept 28, 2023, Vindicator and author Sean Barron). Addressing the impact of the trip, Mr. Rodges said "It's hard to tell what impacted me the most, but it was moving to walk on the same path as the Children's March and to be in the shoes of Martin Luther King in Memphis," (Sept 28, 2023, Vindicator and author Sean Barron).

Thank you to Penny Wells and Sojurn to the Past for this amazing oppurtunity and for their continued efforts in education and black American history.

Marsy's Law Training

Prosecutor DeGenova and Chief of Criminal Ralph Rivera spoke to officials about recent changes to Marsy's Law. Over 50 officials attended, representing agencies throughout the county and Ohio.

Marsy's Law, named for Marsy Nicholas, who was murdered by her ex-boyfriend in 1983, was enacted by voters in November 2017 as an amendment to Ohio's Constitution. California was the first state to adopt Marsy's Law in 2008; Ohio is the sixth state to adopt the constitutional amendment, also known as the Ohio Crime Victim's Bill of Rights. In April 2023, the Ohio Legislature expanded victim protections under Marsy's Law with newly enacted and amended laws.

Notable Cases

State v. Miller

Assistant Prosecutors Jennifer Paris and Katherine Jones successfully prosecuted 38-year-old Jerome Miller, who has been found guilty of multiple drug charges, including possession of more than 1,800 grams of Cocaine. The Mahoning Valley Law Enforcement Task Force initiated their investigation into Miller in 2021. Miller was found guilty of the following charges: Possession of Cocaine, a First-degree Felony with a Major Drug Offender Specification; Possession of a Fentanyl-related Compound, a Second-degree Felony; Aggravated Possession of Drugs, a Third-degree Felony; and Possession of a Fentanyl-related Compound, a Fourth-degree Felony. Before trial, Miller pleaded guilty to three counts of Trafficking in Cocaine and three counts of Trafficking in a Fentanyl-related compound. Miller will be sentenced at a later date.

State v. Bruno

A Boardman man, Michael Bruno Jr., 49, has been found guilty of murder and guilty of a firearm specification in the tragic case of his 74-year-old father, Michael Bruno Sr., back in September 2022. Michael Bruno Jr. has been sentenced to life in prison with eligibility for parole after 18 years. The victim's son was apprehended by police outside the home and subsequently entered his plea. The Mahoning County Prosecutor's Office extends its heartfelt appreciation to Jennifer M. Paris for her unwavering commitment to justice in this case, ensuring that the perpetrator is held accountable for this heinous crime.

CIVIL DIVISION NEWS

For well over a decade, the Academy of Continuing Legal Education though the efforts of Academic Coordinator Attorney Christopher J. Mallin has facilitated a seminar for Ohio election officials and attorneys who practice in the area of election law. Ohio Law requires the Ohio Secretary of State to establish a program for the instruction of members of boards of elections and employees of boards in the rules, procedures, and law relating to elections. Under Ohio Law each board of elections member and employee is required to complete the training program within six months after their original appointment or employment, and to receive continuing education once every four years thereafter. Attorneys are also required to complete twenty-four hours of continuing legal education training every two years that must also include training on attorney professional conduct.

The Academy Election Law Seminar typically is presented bi-annually and provides current and crucial information on court decisions affecting Ohio Election Law, recent election law legislation, Ohio Secretary of State Directives, SOS Advisories, campaign finance, and the Ohio Elections Commission's authority and procedures.

Since 2009, Chief Assistant Prosecutor Linette Stratford has presented the ethics and attorney professionalism portion of the seminar. Attorney Stratford, who is also an adjunct professor of Ethics and Philosophy at Youngstown State University, provides instruction on the topics of Disciplinary Issues for Attorneys Who Hold Public Office and Ethical Considerations for Attorneys Representing County Township and Local Government Agencies.

The Academy Election Law seminar attracts election officials, elected prosecutors, assistant prosecutors, private attorneys and law makers from across Ohio. We thank Attorney Mallin for his dedication and work to provide vital input for all attendees to insure fair and accurate elections in Ohio.

The next Academy of Continuing Legal Education Ohio Election Law Seminar will be held on December 6, 2023 in Richfield, Ohio.
