

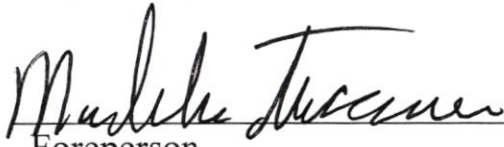
Report of Grand Jury
